4. All the candidates have to declare his/her name, designation, nature of duties, relationship in advance in writing during sending of the application form, if any of his near or distant relative is an employee of the PPVFR Authority.
5. The candidates will have to compulsorily filled in application form (as per the format annexed), all the scanned certificates from matriculation onwards, date of birth certificate, NET/equivalent certificate, degree certificate either original or provisional and a recent photograph enclosed onto the application form. Proof of experience and publications also need to be sent by email and in single PDF file.
6. All original or provisional degree/mark sheets from Secondary examination onwards, Date of Birth proof, UG/PG certificates/Grade cards/mark sheets, credentials, working experience, if any, will have to be produced by the successful candidate at the time of joining for verification, failing which, the offer of appointment will be deemed cancelled.
7. The date of interview will be communicated in due course to the eligible candidates only.
8. If any candidate is found to have submitted false claims at later stage, their candidature will be summarily rejected
9. The posts are purely temporary and will be filled on contractual basis initially for one year which may be extended periodically subjected to performance or till the termination of the project.
