The Protection of Plant Varieties and Farmers' Rights Authority invites applications for filling up of the post of **Registrar-General equivalent to rank of (Additional Secretary, Govt. of India)** on deputation or contract basis at PPV&FR Authority.

**AGE LIMIT FOR THE POSTS:** Candidates should not exceed 58 years of age at the time of making application. The eligibility, educational qualifications, experience and other conditions for the post is given below:-

REGISTRAR GENERAL-(Number of post -1) Rs. 182200-224100/- in Level-15 of 7th CPC and other admissible allowances as per Central Government Rules.

**Essential:**

**(1) Educational qualification:**

- A. Doctorate degree in Plant Breeding and Genetics or Plant Breeding or Genetics (on plant species) or Doctorate degree in Agriculture or Horticulture or Botany or Forestry with specialization in Plant Breeding and Genetics or Plant Breeding or Genetics; and
- B. Master's degree in Agriculture or Horticulture or Botany or Forestry with Specialization in Plant Breeding and Genetics or Plant Breeding or Genetics; and
- C. Bachelor's Degree in Agriculture or Horticulture or Horticulture & Forestry.

**Experience:**

- (2) For appointment on deputation basis a person shall be an officer under Central or State Governments or Union Territories Administration or Universities/ or Statutory Organization or an Autonomous Body under the Central Government or of the Indian Council of Agricultural Research.
  - (i) A person having proven managerial, legal or Intellectual Property Rights or agricultural development experience.
  - (ii) Holding analogous post on regular basis in the parent cadre/department; or
  - (iii) Three years service in the grade rendered after appointment thereto on a regular basis in post in level-14 (Rs. 144200 – 218200) in the pay matrix

**Note:** Period of deputation (including short term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Govt. shall ordinarily not exceed 5 years.

- (3) The maximum age limit for appointment by deputation or on contract basis shall not exceed 58 years as on the closing date of receipt of application.
- (4) The term of office of the Registrar-General shall be for a period of 5 year or until he attains the age of 60 years whichever is earlier.

**Last date for receipt of applications is 30 days from the date of advertisement in the Employment News.**
